

## **The Markham Berczy Veterans of the War of 1812**

The 1<sup>st</sup> York Militia was mustered from the York County townships north of the Town of York. All of the Markham Berczy men between the ages of 16 and 60 would have been required by law to muster for militia duty. Those unfit or providing an essential service would have been recorded and sent home again. The qualifying men would have probably been formed into a company and have been marched to Fort York. At the fort, they may have been transferred into one of the other nine companies or detachments in the 1<sup>st</sup> York or into other militia or provincial corps also stationed at the fort. It therefore was not unusual to find the men serving under a number of different officers.

Some of the younger men were recruited into the special militia flank companies in 1812 and were also recruited in the Incorporated Militia in 1813. These men were required to train to engage the Americans in battle and were to serve for extended periods of time. Most militia men never engaged the Americans. A several of these settlers also served in Captain John Button's Cavalry and in other mounted troops.

A major problem in identifying the Berczy veterans was the number of variations in the spelling of surnames. Generally, English speaking officials and officers Anglicized foreign sounding names and did not all use the same spelling. Other spelling problems resulted from illegible hand writing and the process of duplicating documents by hand under poor lighting conditions. A related problem was the presence of families in the county with the same surname who were not Berczy Settlers. The most numerous were the Smith families.

Compiling a list of veteran service records has therefore been done with various degrees of probable accuracy because of these and other problems.

The surviving document collections are incomplete for a number of reasons and while there is more than one collection for some militia regiments, only one has been found for the 1<sup>st</sup> York Militia. The 1<sup>st</sup> York engaged the Americans on four different occasions but none of the rolls for those engagements has yet been found. Rolls for the defence of Fort York on April 27, 1813, when the Americans captured it and the town, were probably never written because the British and a number of militia officers had hurriedly fled to Kingston. As for the rolls for the Capture of Fort Detroit and the Battle of Queenston Heights in 1812, they may have been taken or destroyed by the Americans in 1813. The fourth battle was the defence of Fort Michilimackinac by Captain Robinson's Company on July 26, 1814.

However, George Buckindall received a medal for his services at the Capture of Fort Detroit in 1812 so some of the 1<sup>st</sup> York men must have been there with him. There are also documents recording the names of men who were captured at Fort York in 1813. Most of these men were paroled. They could still serve in the militia but could not bear arms against Americans until their parole was rescinded.

During the American occupation of York, the senior ranking British officer in the town was a militia ensign. Ensign Henry Pingle commanded a detachment of the 1<sup>st</sup> York Militia men who included some of the Berczy men. These men served from April 27<sup>th</sup> to 29<sup>th</sup> and represented the absent British officials.

An explanation of some of the militia terms used in the rolls will help the reader better understand how these men served. The most disturbing remark beside an ancestor's name might be "deserted". This did not refer to desertion to the enemy, but absence from a muster. A man may have failed to report for duty or left the company after having served for a number of days. There was a fine for desertion. The British were aware that they were dependant on the Upper Canadians to supply their army and wanted to keep them loyal to the Crown. Desertion was common, particularly in 1812, and fines were rarely imposed.

"On command" referred to service away from the company or detachment. In the summer of 1814, Private George Henry Summerfeldt was on command at Nottawasaga while the remainder of his company was probably stationed near York. His "public service" at other times might have included road maintenance. "Returns" were lists or charts. Cavalry troopers were paid with the rank of private.

The veterans listed below were probably all Markham Berczy Settlers. Many have been confirmed with the aid of family histories and other sources. Some are recorded as "not confirmed" and the possibility exists that they were not members of these families in Markham Township even though their surnames were similar. Further research is required to clarify who they were.

As you can see, this is still a work in progress. Thank you to all the family members who contributed family history for this memorial. Please help us confirm more veterans and fill in missing family history for those that have been identified.

## Markham Berczy Veterans, Their Service Records, and Family Histories

### Officers

#### **Lieutenant John George Schultz (1768-)**

From Oct. 17, 1812 to Jan. 24, 1813, he served in Capt. Willson's Co. (1Y21)(1Y103)(1Y232)(1Y314).

From Jan. 25 to Apr. 24, 1813, he served in Capt. Willson's Co. (1Y33)(1Y37)(1Y420). From Sept. 25 to Oct. 3, 1813, he was on command for deserters from Capt. Arnold's Co. (1Y59)(1Y482).

From Mar. 8 to 11, 1814, he was taking resource returns (1Y94). From July 8 to 27, 1814, he served in Capt. Fenwick's Co. (1Y389)(1Y470). From Sept. 1 to 3, 1814, he was taking lists of Menonists and Tunkers (1Y94). From Oct. 10 to 12, 1814, he was collecting wheat for the commissariat (1Y94).

John George Schultz settled on Lot 13, Con. 3.

#### **Ensign Henry Pingle (1784-)**

In 1812, he served in Capt. Button's Cavalry (1Y90a). He was a sergeant in Capt. Button's Troop. On Dec. 25, 1812, he was commissioned as an ensign (OBF).

From Apr. 27 to 29, 1813, he commanded a company at York (1Y139). From June 28 to July 16, 1813, he served in Mjr. Wilmot's Detachment (1Y1). From July 21 to 25, 1813, he was at the York at the Alarm (1Y100a). From Aug. 27 to Sept. 3, 1813, he was working on Dundas Street (1Y104a). From Sept. 20 to 24, 1813, he was at York in Capt. Richardson's Detach. (1Y182). From Sept. 25 to Oct. 3, 1813, he was on duty in Capt. Fenwick's Co. (1Y63)(1Y482).

From July 18 to 27, 1814, he served in Capt. Travis' Co. (1Y386)(1Y443). From Aug. 6 to 9, 1814, he served at York at an Alarm in Capt. Fenwick's Co. (1Y102). From Nov. 13 to Dec. 10, 1814, he served at York in a mixed detachment under Capt. Heward (1Y117b)(1Y121).

About 1827, Henry Pingle, a farmer of Markham Twp. and a former sergeant in Capt. Button's Cavalry Co. of the 1st York Militia, received 200 acres. He did not claim his location and an Order in Council awarded him script on Apr. 21, 1847 (MLG148).

Henry was the son of Joachim & Anna Maria Pingel. Joachim settled on Lot 22, Con. 5. Henry settled on Lot 25, Con. 4.

**Non-Commissioned Officers and Rank and File  
In Alphabetical Order**

**Private George Buckindall (c1789-1846)**

In 1812, he served in Capt. Button's Cavalry (1Y90a). He received the General Service Medal for the Capture of Fort Detroit.

From Sept. 25 to Oct. 3, 1813, he served in Capt. Button's Cavalry (1Y52). From Dec. 28, 1813 to Jan. 9, 1814, he served in Capt. Selby's Detachment escorting prisoners of war from York to Hamilton Twp. (1Y109c).

From Apr. 26 to May 4, 1814, he served in Capt. Travis' detachment employed on public service at York (1Y49). From July 21 to 24, 1814, he served in Capt. Selby's Co. (1Y306). From July 25 to Sept. 24, 1814, he was on duty in Whitby with a cavalry detachment (1Y334)(1Y366).

On Apr. 4, 1820, George Buckindall, a farmer of Markham Twp. and a former private in Capt. Button's Cavalry of the 1st York Militia, received 100 acres on the north half of Lot 8, Con. 14, Innisfil Twp. (MLG170).

George was born in Germany to Peter Buckendahl. In 1813, he married Anna Catharina Amelia Helmkey.

**Private Francis Denny (c1768-)**

From Aug. 6 to Oct. 24, 1812, he served in Capt. Selby's Co. (1Y90c). From Nov. 25 to Dec. 24, 1812, he served in Capt. Selby's Co. (1Y216).

Francis Dunny applied for a militia land grant (YS page 180).

Francis Dunney, a farmer of Markham Twp. and a former private in a flank company of the 1st York Militia, received 100 acres on the south half of Lot 15, Con. 3, Innisfil Twp. on May 30, 1820 (MLG595).

Francis Dunne settled on Lot 11, Con. 1 Markham Twp. In 1804, he was on Lot 10, Con. 2.

**Private John Ditsman (1769-)**

In 1812, he served in Capt. Selby's Flank Co. (1Y90a). From Aug. 6 to Oct. 24, 1812, he served in Capt. Selby's Co. (1Y90c). From Nov. 25 to Dec. 24, 1812, he served in Capt. Selby's Co. (1Y216).

On Apr. 27, 1813, at the Capture of York a number of men from the Incorporated Militia committed acts of sabotage. The Americans were unable to identify the men involved and randomly selected five militia men to punish. Private John Deetsman and the others were charged with breaking their parole and they were taken prisoner and conveyed to the United States. (RP pg. 86)

On July 27, 1820, John Destman, a farmer of York Twp. and a former private in the Incorporated Militia, received 100 acres on the north half of Lot 8, Con. 7, Brock Twp. (MLG12).

John Dietzmann was born in 1769. He settled on Lot 24, Con. 2, Markham Twp. He died in Oct., 1795 and his family remained on the farm. Another John Dietzmann settled on Lot 22, Con. 1 and died before 1798.

**Private Godfrey Eckhart (Not confirmed)**

From Nov. 14 to Dec. 10, 1814, he served at York in a mixed detachment under Capt. Heward (1Y117b)(1Y121).

Phillip Eckhard was a Markham Berczy Settler.

**Private Philip Eckhard (1764-)**

From Apr. 27 to 29, 1813, he served with Ensign Pingle at York (1Y139). From Sept. 25 to Oct. 3, 1813, he was absent with leave from Capt. Fenwick's Co. (1Y63).

From Aug. 6 to 9, 1814, he served at York at an Alarm in Capt. Fenwick's Co. (1Y102).

Phillip Eckhard/Eckhardt was born in 1764. He settled on Lot 7, Con. 5, Markham Twp. In 1794, he worked for the German Company.

**Private John Geister (1768-1821)**

From Oct. 20 to Nov. 17, 1813, he was at York in Capt. Richardson's Co. (1Y201)(1Y227).

John was born in Germany to Johann & Margaretha Geister. John settled on Lot 18, Con. 3, Markham Twp. In 1810, he married Mary Palmer in Markham. In 1817, he had a child born in Markham. He died in Michigan.

**Private John Grateman (1770-)**

From July 8 to 27, 1814, he served in Capt. Fenwick's Co. (1Y389)(1Y470).

John Gretmann was born in 1770. He settled on Lot 8, Con. 1, Markham Twp.

**Private Nicholas Hagerman (1780-1838)**

In 1812, he served in Capt. Button's Cavalry (1Y90a).

From Sept. 25 to Oct. 3, 1813, he served in Capt. Button's Cavalry (1Y52).

From July 4 to Sept. 22, 1814, he served in Capt. Selby's Co. (1Y306)(1Y335)(1Y367).

Nicholas then served in the 3rd York Militia. From Dec. 11 to 26, 1814, he was employed impressing teamsters with Capt. Heward (3Y126).

From Jan. 14 to 24, 1815, he served in a detachment employed in the transport service under the command of Lieut. Playter (3Y242). From Jan. 25 to Mar. 24, 1815, he was on command while serving with the same detachment (3Y248)(3Y250).

On Apr. 4, 1820, Nicholas Hagerman, of Markham Twp. and a former private in Capt. Button's Cavalry of the 1st York Militia, received 100 acres on the north half of Lot 19, Con. 9, Innisfil Twp. (MLG166).

Nicholas was born on Nov. 8, 1780. Nicholas Hagemann settled on Lot 6, Con. 4. On Mar. 16, 1838, he died and was buried in the Hagerman West Cemetery in the Town of Markham (FindAGrave).

### **Private Frederick Hederick (Not confirmed)**

From June 28 to July 6, 1813, he served in Mjr. Wilmot's Detachment and deserted on the 6th (1Y1).

Markham Berczy Settler Johann Frederick Hederich was born in 1757.

### **Private Francis Helmke/Helmkey**

In 1812, he served in Capt. Button's Cavalry (1Y90a).

From Sept. 25 to Oct. 3, 1813, he served in Capt. Button's Cavalry (1Y52). From Dec. 28, 1813 to Jan. 9, 1814, he served in Capt. Selby's Detachment escorting prisoners of war from York to Hamilton Twp. (1Y109c).

From July 21 to 24, 1814, he was on guard in Capt. Selby's Co. (1Y306). From July 25 to Sept. 24, 1814, he was on duty in Scarborough with a cavalry detachment (1Y334)(1Y366).

On Apr. 4, 1820, Francis Helmke, a farmer of Markham Twp. and a former private in Capt. Button's Cavalry of the 1st York Militia, received 100 acres on the south half of Lot 8, Con. 14, Innisfil Twp. (MLG169).

Francis was the half-brother of Frederick as he was the son of Johan Helmke and Mary Ann Stober/Stiver.

### **Private Frederick Helmke/Helmkey (1770-1857)**

In 1812, he served in Capt. Button's Cavalry (1Y90a). From Sept. 29 to Nov. 17, 1812, he was in Delaware with Peter Ritter.

From Sept. 22 to 24, 1813, he was at York in Capt. Richardson's Detach. (1Y182). From Sept. 25 to Oct. 24, 1813, he was at York in Capt. Richardson's Co. (1Y201).

From May 6 to 12, 1814, he served in Capt. Travis' detachment employed on public service at York (1Y49). From July 8 to 27, 1814, he served on command in Capt. Button's Cavalry (1Y410a)(1Y439b). From Aug. 25 to Sept. 24, 1814, he was on duty in Pickering with a cavalry detachment (1Y366).

On Apr. 4, 1822, Frederick Helmke, a farmer of Markham Twp. and a former private in Capt. Button's Cavalry of the 1st York Militia, received 100 acres on the south half of Lot 9, Con. 14, Innisfil Twp. (MLG168). The certificate of service recorded that he had served a year in the cavalry up to July 2, 1813. He sold his land grant in 1826.

Wikitree.com Helmkey-13: He was born in Germany to Johan Englehad Helmke. In 1814, he married Nancy Anne Weisz. In 1815, he had a child born in York Co. He died in Whitchurch.

In 1792, the family left Germany for Philadelphia and travelled through Pennsylvania and New York State. In 1794, Frederick was granted Lot 8, Con. 3 or 4, Markham Twp. but sold it back to William Berczy to pay off a debt. The lot was then sold to Joachim Lunau. In 1837, he was living in Whitchurch Twp. On Apr. 30, 1857, he died and was buried in Bloomington Cemetery.

**Private Nathaniel Holmes (Not confirmed)**

From Oct. 18 to 24, 1812, he served in Capt. Arnold's Co. (1Y117a).  
Niels Holms was a Markham Berczy Settler.

**Private Niels P. Holms/Holm/Helm (1776-)**

From Oct. 17 to 24, 1812, he served in Capt. Willson's Co. (1Y21).  
From Oct. 25, 1812 to Jan. 24, 1813, he served in Capt. Willson's Co.  
(1Y103)(1Y232)(1Y314).

From Jan. 25 to Feb. 24, 1813, he was sick at home from Capt. Willson's Co.  
(1Y33). From Feb. 25 to Mar. 24, 1813, he was on contract with the King's Works from  
Capt. Willson's Co. (1Y37). From Sept. 20 to 24, 1813, he was at York in Capt.  
Richardson's Detach. (1Y182). From Sept. 25 to Oct. 15, 1813, he was at York in Capt.  
Richardson's Co. (1Y201).

From July 20 to 24, 1814, he was on duty in Capt. Fenwick's Co. (1Y389).  
Neils Holme/Holm/Holms settled on Lot 7, Con. 1, Markham Twp.

**Private Frederick Koepke (1782-)**

From July 1 to Oct. 24, 1812, he served in Capt. Selby's Co. (1Y90c). From Nov.  
25 to Dec. 24, 1812, he served in Capt. Selby's Co. (1Y216).

From Sept. 25 to Oct. 3, 1813, he was absent without leave from Capt. Fenwick's  
Co. (1Y63). From Oct. 28 to Nov. 24, 1813, he served in Capt. James Mustard's Co. at  
York (1Y225).

From July 8 to 24, 1814, he was in the commissariat from Capt. Fenwick's Co.  
(1Y389). From Oct. 15 to 24, 1814, he served in Capt. Heward's mixed detachment  
(1Y120). From Oct. 25 to Dec. 10, 1814, he served at York in a mixed detachment  
under Capt. Heward (1Y117b)(1Y121).

On Feb. 16, 1821, Frederick Kipley, a yeoman of Markham Twp. and a former  
private in a flank company of the 1st York Militia, received 100 acres on the south half of  
Lot 11, Con. 12, Innisfil Twp. (MLG1890).

A Frederic Koepke settled on Lot 7, Con. 2 and died before 1798.

**Private Jacob Lunan/Lunau (Not confirmed)**

From Sept. 25 to Oct. 3, 1813, he served in Capt. Arnold's Co. (1Y59). From  
Oct. 19 to 24, 1813, he was at York in Capt. Richardson's Co. (1Y201). From Oct. 25 to  
Nov. 19, 1813, he served at York in Capt. Richardson's Co. (1Y227).

From July 8 to 24, 1814, he deserted from Capt. Fenwick's Co. (1Y389). From  
July 16 to Sept. 22, 1814, he served in Capt. Selby's Co. (1Y306)(1Y335)(1Y367).

Markham Berczy Settler Joachim Lunau (1770-) settled on Lot 14, Con. 1  
Markham Twp.

### **Corporal George Munshaw**

In 1812, he served as a private in Capt. Button's Cavalry (1Y90a).

From June 28 to July 16, 1813, he served in Mjr. Wilmot's Detachment (1Y1). From Dec. 25, 1813 to Jan. 22, 1814, he served as a private at York in Capt. Richardson's Co. (1Y71).

From July 8 to 27, 1814, he served in Capt. Fenwick's Co. (1Y389) (1Y470). From Sept. 10 to 24, 1814, he was on command from Capt. Selby's Co. (1Y367). From Sept. 28 to Oct. 16, 1814, he served with Capt. Mustard (1Y410b).

On Oct. 25, 1826, George Munshaw, a farmer of Vaughan Twp. and a former private in Capt. Button's Troop of Cavalry of the 1st York Militia, received 100 acres on part of Lot 2, Con. 6, Innisfil Twp. (MLG289).

George was the son of Balthasar and Katherine Munshaw.

### **Private Jacob Munshaw (1789-1867)**

From Aug. 22 to Oct. 24, 1812, he served in Capt. Selby's Co. (1Y90c).

On Oct. 25, 1826, Jacob Munshaw, a yeoman of Vaughan Twp. and a former private in Capt. Selby's Flank Co. of the 1st York Militia, received 100 acres on the north half of Lot 1, Con. 6, Innisfil Twp. (MLG2283).

Jacob was the son of Balthasar and Katherine Munshaw. He married Nancy Miller. On June 7, 1867, he died in Richmond Hill and was buried in Richmond Hill Pres. Cemetery.

### **Private John Munshaw**

From Aug. 24 to Sept. 10, 1813, he was employed in the bateaux service in Lieut. Miles' Detachment (1Y122). From Dec. 25, 1813 to Jan. 3, 1814, he served at York in Capt. Richardson's Co. (1Y71).

From July 8 to 27, 1814, he served in Capt. Fenwick's Co. (1Y389)(1Y470).

John was the son of Balthasar and Katherine Munshaw.

### **Private William Munshaw (1797-1846)**

From Nov. 11 to 24, 1813, he served at York in Capt. Richardson's Co. (1Y227).

From May 7 to 12, 1814, he served in Capt. Travis' detachment employed on public service at York (1Y49). From July 8 to 27, 1814, he served in Capt. Fenwick's Co. (1Y389)(1Y470). From Sept. 10 to 24 1814, he was on command from Capt. Selby's Co. (1Y367). From Sept. 28 to Oct. 16, 1814, he served with Capt. Mustard (1Y410b).

William was born on Mar. 23, 1797, in Markham to Balthasar and Katherine Munshaw. He married Rebecca Devins. On July 12, 1846, he died in Richmond Hill and was buried in Richmond Hill Pres. Cemetery.



**Private Godfrey/Godfied Philips (Not confirmed)**

In 1812, he served in Capt. Button's Cavalry but deserted (1Y90a).

From Sept. 25 to Oct. 3, 1813, he served in Capt. Button's Cavalry (1Y52).

From July 18 to 24, 1814, he served in Capt. Selby's Co. (1Y306). From July 25 to Sept. 24, 1814, he was on duty at the Humber with a cavalry detachment (1Y334)(1Y366).

Godfrey Philips, of Burford Twp. and a former private in Capt. Button's Cavalry of the 1st York Militia, received 100 acres Lot 46, Con. 12, Collingwood Twp. on Dec. 4, 1834 (MLG3581).

Markham Berczy Settlers Peter Gotfried Philippsen settled on Lot 4, Con. 5.

From July 8 to 24, 1814, he deserted from Capt. Fenwick's Co. (1Y389).

Markham Berczy Settlers Peter Gotfried Philippsen settled on Lot 4, Con. 5.

**Private George Pingle (1770-)**

From Apr. 27 to 29, 1813, he served with Ensign Pingle at York (1Y139). From Sept. 25 to Oct. 3, 1813, he was absent with leave from Capt. Fenwick's Co. (1Y63).

From Aug. 6 to 9, 1814, he served at York at an Alarm in Capt. Fenwick's Co. (1Y102).

George was the son of Joachim & Anna Maria Pingel. He settled on Lot 21 or 25, Con. 5, Markham Twp. Between 1800 & 1803, he married Mary Koepke.

From Apr. 27 to 29, 1813, he served with Ensign Pingle at York (1Y139). From July 21 to 24, 1813, he was at the York at the Alarm (1Y100a). From Oct. 25 to Nov. 24, 1813, he was on duty at the Credit from Capt. James Mustard's Co. (1Y225).

John Henry was the son of Joachim & Anna Maria Pingel. John Henry Pingel settled on Lot 22, Con. 6.

**Private Josiah Pingle (Not confirmed)**

From July 25 to 27, 1814, he was absent without leave from Capt. Fenwick's Co. (1Y470).

**Private Frederick Quantz (1782-1876)**

From June 28 to July 6, 1813, he served in Mjr. Wilmot's Detachment and deserted on the 6th (1Y1).

From Feb. 26 to Mar. 24, 1814, John Ritter served as his substitute in a detachment employed in public service at York (1Y104b). From July 8 to 27, 1814, he served in Capt. Fenwick's Co. (1Y389)(1Y470). From Aug. 6 to 9, 1814, he served at York at an Alarm in Capt. Fenwick's Co. (1Y102).

Frederick was born in England to Mechior & Christina Quantz of Germany. He married Eliz. Ritter (1791-1876).

**Private George Quantz (1783-1873)**

In 1812, he served in Capt. Button's Cavalry (1Y90a).

From June 28 to July 16, 1813, he served in Mjr. Wilmot's Detachment (1Y1). From Sept. 25 to Oct. 3, 1813, he was absent with leave from Capt. Button's Cavalry (1Y52).

From June 25 to July 24, 1814, he served in Capt. Selby's Co. (1Y306). From July 25 to Aug. 24, 1814, he served in Capt. Selby's Co. (1Y335). From Aug. 25 to Sept. 10, 1814, he was on command from Capt. Selby's Co. (1Y367).

On Apr. 6, 1820, George Quantz, a farmer of Markham Twp. and a former private in Capt. Button's Cavalry of the 1st York Militia, received 100 acres on the south half of Lot 14, Con. 9, Innisfil Twp. (MLG185).

George was born in Germany to Mechior & Christina Quantz. He married Mary Ann Baetger (1788-) in 1807. He died in Whitchurch Twp.

**Private Charles Ritter (Not confirmed)**

From Sept. 25 to Oct. 3, 1813, he was absent with leave from Capt. Fenwick's Co. (1Y63).

Christian and John Ritter were Markham Berczy Settlers.

**Private John Ritter**

From Feb. 26 to Mar. 24, 1814, he served in a detachment employed in public service at York as a substitute for Frederick Quantz (1Y104b). From Mar. 25 to Apr. 5, 1814, he served on public service at York in Capt. Travis' Co. (1Y30).

John Charles Ritter settled on Lot 16, Con. 2.

**Private Joshua Ritter (Not confirmed)**

From July 8 to 24, 1814, he deserted from Capt. Richardson's Company (1Y382).

Christian Ritter was a Markham Berczy Settler.

**Private Peter Ritter (Not confirmed)**

In 1812, he served in Capt. Button's Cavalry (1Y90a). From Sept. 29 to Nov. 17, 1812, he was in Delaware with Peter Ritter.

From Sept. 25 to Oct. 3, 1813, he was absent with leave from Capt. Button's Cavalry (1Y52). From Dec. 28, 1813 to Jan. 9, 1814, he served in Capt. Selby's Detachment escorting prisoners of war from York to Hamilton Twp. (1Y109c).

From Feb. 23 to 24, 1814, he was employed in public service at York in Capt. Richardson's Co. (1Y90b). From July 8 to 27, 1814, he served on command in Capt. Button's Cavalry (1Y410a)(1Y439b).

On Apr. 1, 1820, Peter Ritter, a farmer of Markham Twp. and a former private in Capt. Button's Cavalry of the 1st York Militia, received 100 acres on the north half of Lot 7, Con. 9, Innisfil Twp. on Apr. 1, 1820 (MLG153).

Christian and John Ritter were Markham Berczy Settlers.

**Private Henry Rumohr (Not confirmed)**

From Mar. 21 to 24, 1814, he served in a detachment employed in public service at York (1Y104b).

John (Hans) Rumohr was a Markham Berczy Settler.

**Private John Rumohr**

From Apr. 10 to 24, 1813, he was on command for a deserter from Capt. Robinson's Co. (1Y439a). From Sept. 25 to Oct. 3, 1813, he was absent with leave from Capt. Fenwick's Co. (1Y63).

From Mar. 25 to Apr. 21, 1814, he served on public service at York in Capt. Travis' Co. (1Y30). From July 8 to 27, 1814, he served in Capt. Fenwick's Co. (1Y389)(1Y470).

On Dec. 27, 1802, John Rumohr made a land petition as a farmer in Markham Twp. for a lease on Lot 16, Con. 6 or Lot 15, Con. 5. The petition was recommended for this clergy reserve land. Marcus Rumohr, a farmer of Markham Twp., on the same day, petitioned for the lease of Lot 15, Con. 5.

Markham Berczy Settler John (Hans) Rumohr was born in 1772. Marcus Rumohr was born in 1774. John settled on Lot 17, Con. 3, Markham Twp.

**Private Christian Smith (1790-)**

From Apr. 27 to 29, 1813, he served with Ensign Pingle at York (1Y139).

Christian was born in Germany to Francis A. & Caroline Smith. He married Eliz. Size.

### **Private Francis/Frank A. Smith/Smyth (1766-1852)**

From Apr. 10 to 24, 1813, he served in Capt. Robinson's Co. (1Y439a). From Apr. 27 to 29, 1813, he served with Ensign Pingle at York (1Y139). From July 21 to 24, 1813, he was at the York at the Alarm (1Y100a). From Sept. 25 to Oct. 3, 1813, he was absent with leave from Capt. Fenwick's Co. (1Y63). From Dec. 28, 1813 to Jan. 9, 1814, he served in Capt. Selby's Detachment escorting prisoners of war from York to Hamilton Twp. (1Y109c).

From Jan. 23 to 24, 1814, he served in Capt. Richardson's Co. (1Y71). From Jan. 25 to Feb. 24, 1814, he was employed in public service at York in Capt. Richardson's Co. (1Y90b). From Mar. 21 to 24, 1814, he served in a detachment employed in public service at York (1Y104b). From Mar. 25 to Apr. 21, 1814, he served on public service at York in Capt. Travis' Co. (1Y30). From July 8 to 24, 1814, he served in Capt. Fenwick's Co. (1Y389). From July 18 to 27, 1814, he served in Capt. Travis' Co. (1Y386)(1Y443). From Oct. 21 to 24, 1814, he served in Capt. Heward's mixed detachment (1Y120). From Nov. 25 to Dec. 10, 1814, he served in Capt. Heward's mixed detachment (1Y117b).

On Mar. 14, 1766, Frantz Andreas Schmidt was born in Germany. He married Caroline in Germany & Sarah Sipes on Jan. 23, 1811. On Mar. 19, 1852, he died in Markham. The 1851 Census recorded him at 85 and a widower on Lot 16, Con. 5, Markham where he moved in 1804 after settling on Lot 14, Con. 2 in 1794.

### **Private Francis H. Smith Jr. (1796-)**

From Oct. 16 to 20, 1812, he served at York in Capt. Fenwick's Co. (1Y134). From Sept. 25 to Oct. 3, 1813, he served in Capt. Fenwick's Co. (1Y63). From Sept. 5 to Oct. 15, 1814, he served in a detachment at Nottawasaga (1Y472).

Frank was born in Markham to Francis A. & Caroline Smith. On Jan. 29, 1822, he married Anna Catherine Wagner.

### **Private John Spanhouse (c1790-)**

In 1812, he served as a trumpeter in Capt. Button's Cavalry (1Y90a).

From June 28 to July 16, 1813, he served in Mjr. Wilmot's Detachment (1Y1). From Sept. 25 to Oct. 3, 1813, he was absent with leave from Capt. Button's Cavalry (1Y52).

From July 22 to 24, 1814, he served in Capt. Selby's Co. (1Y306). From July 25 to Aug. 24, 1814, he was on duty in Pickering with a cavalry detachment (1Y334).

On Oct. 9, 1815, John Spanhouse received the patent to 200 acres of Lot 13, Con. 6, Markham Twp. He sold his last part of this property in 1859.

On Apr. 6, 1820, John Sponhouse, a farmer of Markham Twp. and a former private in Capt. Button's Cavalry of the 1st York Militia, received 100 acres on the south half of Lot 15, Con. 9, Innisfil Twp. but received scrip on May 19, 1845 (MLG186).

The 1852 Markham Census had John Spanhouse on Lot 13, Con. 6.

John was the son of John (1766-c1804) and Sophia Spannaus. John Sr. died before 1804.

**Private John Stamm/Stam (Not confirmed)**

In 1812, he served in Capt. Button's Cavalry (1Y90a).

From Apr. 27 to 29, 1813, he served with Ensign Pingle at York (1Y139). From June 28 to July 16, 1813, he served in Mjr. Wilmot's Detachment (1Y1). From Sept. 25 to Oct. 3, 1813, he served in Capt. Button's Cavalry (1Y52). From Dec. 28, 1813 to Jan. 9, 1814, he served in Capt. Selby's Detachment escorting prisoners of war from York to Hamilton Twp. (1Y109c).

From Feb. 25 to Mar. 15, 1814, he served in a detachment employed in public service at York (1Y104b). From July 25 to Sept. 24, 1814, he was on duty in Scarborough with a cavalry detachment (1Y334)(1Y366).

In 1816, John settled on Lot 19, Con. 5 Markham Twp. He was a founding member of St. Philip's Lutheran Church in Unionville. In the 1840s, John moved to Middlesex Co.

John Stamm received a Militia Land Grant on the north half of Lot 13, Con. 12 Innisfil Twp. After the war, he travelled to the township to perform the settlement duties on the farm with George F.H. Warnica but almost drowned on Lake Simcoe while returning. He sold his 100 acres to George soon after for 10 pounds.

Markham Berczy Settler Frederick Stamm was born in 1762. He settled on Lot 19, Con. 4, Markham Twp.

**Private Dedrick Stephens/Stevens/Steffens (Not confirmed)**

From Oct. 16 to 20, 1812, he served at York in Capt. Fenwick's Co. (1Y134).

From Apr. 27 to 29, 1813, he served with Ensign Pingle at York (1Y139).

From July 8 to 27, 1814, he served in Capt. Fenwick's Co. (1Y389) (1Y470).

From Aug. 6 to 9, 1814, he served at York at an Alarm in Capt. Fenwick's Co. (1Y102). From Sept. 25 to Oct. 12, 1814, he served in Capt. Heward's mixed detachment (1Y120).

John Nicholas Steffans was a Markham Berczy Settler.

**Private John Steffens/Steffine (1785-1850)**

From Aug. 6 to Oct. 24, 1812, he served in Capt. Selby's Co. (1Y90c). From Sept. 20 to 24, 1813, he was at York in Capt. Richardson's Detach. (1Y182). From Sept. 25 to Oct. 11, 1813, he was at York in Capt. Richardson's Co. (1Y201).

Markham Berczy Settler John Nicholas Steffans was born in 1785. John Stephens settled on Lot 25, Con. 5. John Nicholas Stephens Sr. settled on Lot 22, con. 4. In 1800, John Stephens was recorded on Lot 22, Con. 4, Markham Twp. He was buried in Trinity Anglican Cemetery in Streetsville, Peel Co.

**Private Weston Stevens/Stephens (Not confirmed)**

From Sept. 25 to Oct. 3, 1813, he was absent without leave from Capt. Mustard's Co. (1Y66). From Oct. 25 to Nov. 24, 1813, he served in Capt. James Mustard's Co. at York (1Y225).

From July 8 to 27, 1814, he served on command in Capt. Button's Cavalry (1Y410a)(1Y439b).

On Dec. 18, 1809, Westen Stephens, a yeoman of Markham Twp., made a land petition. He had been in the township for 3 years and had a wife and five children.

John Nicholas Steffans was a Markham Berczy Settler.

**Private John Henry Stiver (1795-1879)**

In the fall of 1812, he did garrison duty at Fort York in Capt. Arnold's Co. (Stiver family history, but not confirmed by militia rolls.) He served 6 months in Capt. Powell's Artillery. After this he served for 3 years in Capt. Merritt's Cavalry. He was at the Battle of Queenston Heights with Merritt.

On June 16, 1824, John Stiver, a yeoman of St. Catharines and later Markham Township made a war loss claim.

John Henry was the first European child born in Markham. He was the son of Johann Nicholas (1753-) & Anna Stober who had 4 children. He was taken to his mother's sister's home in Niagara for nursing. His parents moved there as well. In 1817, he married Nancy Wagner.

**Private Peter Stiver/Staver/Steves//Staves/Shiver (1775-1858)**

From Oct. 25, 1812 to Jan. 24, 1813, he served in Capt. Willson's Co. (1Y103)(1Y232)(1Y314).

From Jan. 25 to Apr. 24, 1813, he served in Capt. Willson's Co. (1Y33)(1Y37)(1Y420).

From Feb. 20 to 24, 1814, he was employed in public service at York in Capt. Richardson's Co. (1Y90b). From Feb. 25 to Mar. 20, 1814, he served in a detachment employed in public service at York (1Y104b). From July 8 to 24, 1814, he served in Capt. Fenwick's Co. (1Y389).

Peter was the son of John Nicholas Stoeber who was born in 1753. Peter Stoeber settled on Lot 20, Con. 4. On Dec. 29, 1807, he married Agnes Nancy Spring. On Apr. 25, 1858, Peter died and was buried in the St. John's Lutheran Cemetery in Buttonville.

### **Private George Henry Summerfeldt (c1793-1869)**

In 3 documents he was recorded as George Henry and as Henry in the remainder. Family history and the 1803 Census confirm that they were both the same person.

From Sept. 9 to 15, 1812, he served in Capt. Willson's Co. (1Y18). From Dec. 1 to 6, 1812, he served in Capt. Willson's Co. and deserted on the 6th (1Y232).

From Jan. 25 to Mar. 24, 1813, he served in Capt. Willson's Co. (1Y33)(1Y37). From Mar. 25 to Apr. 24, 1813, he was on command at Hamilton from Capt. Willson's Co. (1Y420). From July 21 to 24, 1813, he was at the York at the Alarm (1Y100a). From Sept. 25 to Oct. 3, 1813, he was absent without leave from Capt. Fenwick's Co. (1Y63). From Dec. 28, 1813 to Jan. 9, 1814, he served in Capt. Selby's Detachment escorting prisoners of war from York to Hamilton Twp. (1Y109c).

From Apr. 11 to 22, 1814, he served in a detachment employed on public service at York with Ensign Tyler (1Y34). From June 25 to July 24, 1814, he served in Capt. Selby's Co. (1Y306). From July 25 to Aug. 24, 1814, he was on command at Nottawasaga from Capt. Selby's Co. (1Y335). From Aug. 25 to Sept. 10, 1814, he was on command from Capt. Selby's Co. (1Y367).

Wikitree.com Summerfeldt-10: He was born in the US to John Henry and Eliz. Margaretha Summerfeldt. John Henry was born in 1760. George married Clarissa Ransom and Esther Davis. He died in Markham Twp.

Henry John Sommerfeldt settled on Lot 23, Con. 5. The 1803 Berczy Census, John Henry, age 40, had a son Henry, age 10, but there was no record of George Henry of about the same age.

### **Private William Temple (Not confirmed)**

From Feb. 25 to Mar. 24, 1814, he deserted from a detachment employed in public service at York (1Y104b). From Mar. 25 to Apr. 16, 1814, he served on public service at York in Capt. Travis' Co. (1Y30).

Markham Berczy Settler Mary Tempel & children settled on Lot 18, Con. 2, Markham Twp.

### **Private Philip Vogel/Vagel (1795-1870)**

From July 8 to 24, 1814, he served in Capt. Richardson's Company (1Y382)(1Y440).

Philip was the son of Carl Heinrich Vogel, also known as Charles Henry, and his wife Anna. Charles Henry Vogel settled on Lot 7, Con. 4, Markham. On Sept. 18, 1825, Philip married Clarinda Storey in Pennsylvania. On June 30, 1870, he died in Pine Orchard, Newmarket, Whitchurch Twp.



**Private James Waggoner/Wagnor (Not confirmed)**

From Oct. 25 to Nov. 24, 1812, he served in Capt. Robinson's Co. (1Y100b).

From Apr. 27 to 29, 1813, he served with Ensign Pingle at York (1Y139). From June 28 to July 16, 1813, he served in Mjr. Wilmot's Detachment (1Y1). From Sept. 25 to Oct. 3, 1813, he was absent with leave from Capt. Fenwick's Co. (1Y63). From Dec. 28, 1813 to Jan. 9, 1814, he served in Capt. Selby's Detachment escorting prisoners of war from York to Hamilton Twp. (1Y109c).

From Apr. 27 to May 3, 1814, he served in Capt. Travis' detachment employed on public service at York (1Y49). From July 8 to 24, 1814, he deserted from Capt. Fenwick's Co. (1Y389). From Sept. 28 to Oct. 16, 1814, he served with Capt. Mustard (1Y410b).

Markham Berczy Settler Conrad Wagner was born in 1759. He settled on Lot 7, Con. 3.

**Private William Waggoner/Waggener (Not confirmed)**

From Aug. 6 to Oct. 24, 1812, he served in Capt. Selby's Co. (1Y90c). From Nov. 25 to Dec. 24, 1812, he served in Capt. Selby's Co. (1Y216).

From June 28 to July 16, 1813, he served in Mjr. Wilmot's Detachment (1Y1). From Sept. 25 to Oct. 3, 1813, he served in Capt. Fenwick's Co. (1Y63). From Oct. 28 to Nov. 24, 1813, he served in Capt. James Mustard's Co. at York (1Y225).

From July 8 to 27, 1814, he served in Capt. Fenwick's Co. (1Y389)(1Y470).

On Apr. 11, 1850, William Waggoner, of the Home District and formerly of the 1st York Militia, received 100 acres worth of scrip (MLG5319).

Markham Berczy Settler Conrad Wagner was born in 1759. He settled on Lot 7, Con. 3.

**Private Martin Warner (Not confirmed)**

From Apr. 10 to 24, 1813, he served in Capt. Richardson's Co. (1Y424).

From July 8 to 27, 1814, he was on duty in Capt. Richardson's Company (1Y382)(1Y440).

Markham Berczy Settler Conrad Warner settled on Lot 7, Con. 3, Markham Twp.

**Private John Wickhorn (1766-)**

From July 8 to 27, 1814, he served in Capt. Button's Cavalry (1Y410a)(1Y439b).

On April 18, 1812, John Wickhorn of Markham was appointed as a constable in the General Quarter Sessions of the Peace. He was also appointed in 1832.

On Mar. 3, 1820, John Wickhorn, a shoemaker of Markham Twp. and a former private in a company of cavalry attached to the 1st York Militia, received 100 acres on the east half of Lot 11, Con. 2 Nissouri Twp. (MLG29)

Markham Berczy Settler John Gottlieb Wichur was born in 1766. On Aug. 7, 1792, Johann Gottlieb Wichor married Maria Magdalena Gelson (1770-) in Philadelphia, Pennsylvania. He settled on Con. 2, Markham Twp. In 1794, John was a shoemaker with the German Company.

### **Private Anthony Wunch/Wouch (1791-1867)**

From Sept. 9 to 15, 1812, he served in Capt. Willson's Co. (1Y18). From Nov. 8, 1812 to Apr. 24, 1813, he served in Capt. Willson's Co. (1Y103)(1Y232)(1Y314)(1Y33)(1Y37)(1Y420).

From Sept. 25 to Oct. 14, 1813, he was at York in Capt. Richardson's Co. (1Y201).

From July 8 to 24, 1814, he served in Capt. Richardson's Company (1Y382)(1Y440). From Sept. 5 to Oct. 15, 1814, he served in a detachment at Nottawasaga (1Y472). From Oct. 25 to Nov. 21, 1814, he served at York in a mixed detachment under Capt. Heward (1Y121).

Wikitree.com Wunsch-203: He was born in Germany. In 1807, he married Marie-Josephe Garand in Canada. In 1809, he had a son born in Markham. He died in Oxford County.

Anthony was born in Germany to John George & Mary Wunsch. John George Wunsch settled on Lot 21, Con. 3.
